1. DNS & VADERSKAP BEVESTIGING

1.1 Simmentaler:

1.1 Simmentaler

DNA and sire verification is **compulsory** for all bulls and female animals presented for inspection from 1 January 2020.

1.2 Simmentaler and Simbra:

DNA and sire verification is **compulsory** for all bulls offered on an auction from 1 January 2020.

1.3 Simbra:

DNA and sire verification is already **compulsory** for all bulls presented for inspection from 6 September 2016.

3. GEBOORTEKENNISGEWINGS FORMAAT

Indien die betrokke kalfboek dier nie goedgekeur is op die dag van die veiling nie, mag daardie dier nie in die ring verskyn nie.

3. BIRTH NOTIFICATIONS FORMAT

The office currently accepts birth notifications in any format that is sent to us, even a WhatsApp photo. From 1 January 2020 birth notifications will only be accepted in the followings formats:

- on the webpage (web registrations) – please contact the office for your password.
 - on the webpage under *Forms* is an electronic birth notification Excel form available with the necessary instructions.
 - if you are not computer literate, the above mentioned Excel form may also be completed by hand, as long as it is clearly readable.
 - electronic from the Herdmaster or Bengu program
- Please complete the birth notifications in full to avoid inquiries.

4. DEADLINES FOR SHOWS AND AUCTIONS

From 1 January 2020 we will strictly adhere to the deadlines for show and auction entries. The deadline is **6 weeks** before the show or auction. No late entries will be accepted. We please ask everyone's cooperation so that catalogues can be delivered on time.

5. CALF BOOK ANIMAL IN AN AUCTION CATALOGUE

A calf book animal may appear in the auction catalogue but must be approved by an inspector on the day of the auction. The inspection report must please be sent to the office.

If the calf book animal involved is not approved on the day of the auction, that animal may not appear in the ring.
